

What is Teen Court?

A legally binding alternative to the mainstream justice system offered to child offenders. Teen Court provides the opportunity to make restitution for their offenses through community service, educational classes, and jury service. The court clerk, jury, defense attorney, and prosecuting attorney consists of Teen Court Youth Volunteers. The judge will be a licensed attorney.

Offender Eligibility:


- Between ages 12 and 17
- Allegedly committed a status offense or an act of delinquency equivalent to a misdemeanor if committed by an adult

Volunteer Eligibility:

- Between ages 12 and 17
- Be in satisfactory academic standing
- Respect the Oath of Confidentiality
- Demonstrate maturity, respect, and reliability
- Recommended by a school official


